Energy Employees Occupational Illness Compensation Program

The federal Energy Employees Occupational Illness Compensation Program (EEOICPA) offers compensation to former and current workers employed at U.S. Department of Energy (DOE) facilities for radiation-related cancers and other work-related illnesses resulting from "toxic exposures" while working at these facilities. EEOICPA was established in 2000 by Congress. Its original purpose was to compensate nuclear weapons workers. In 2001, the program was extended to current/former workers from all DOE facilities, and, years later, a Special Exposure Cohort (SEC) was designated for employees, contractors and subcontractors who worked at BNL from January 1, 1947, through December 31, 1993. EEOICPA is administered by the U.S. Department of Labor (with assistance from DOE and the National Institute for Occupational Safety and Health) and hast wo parts. Part B covers cancers caused by exposure to radiation while claimant was employed at a DOE facility. Part E covers illnesses resulting from "toxic exposures," such as asbestosis or other illness from chemical exposures.

Part B

- Offers compensation to a current/former worker or his/her survivors for cancer if either of the following two conditions is met:

1. An estimate of the worker's cumulative workplace radiation dose determines that it was great enough to have caused the worker's particular cancer.

- 2. The worker is determined to be a member of BNL's Special Exposure Cohort.
- Benefits also extended for workers with chronic beryllium disease (lungs) or beryllium sensitization.
- \$150,000 for living claimant (worker) or survivors of deceased worker for each cancer.
- Lifetime medical care for the condition for a living claimant.

- Worker with beryllium sensitization: Coverage of medical workup to determine if worker has actual chronic beryllium disease.

Part E

- Compensation only if illness resulted in disability (cash payment up to \$250,000) based upon number of years worker experienced wage loss due to the illness, or the extent to which the illness impaired the worker.

- Limited survivor benefit (spouse or minor children) if worker had been disabled by the illness during his/her working life.

- Covered illnesses include: cancers determined to have been caused by radiation and other illnesses caused by "toxic exposures."

- Noise-induced hearing loss NOT covered (covered by New York State workers compensation).

Application Process

- Claimant completes application forms available from EEOICPA web site or by calling or writing EEOICPA "Resource Center" in Amherst, NY.

- Claim forms and required documentation mailed to U.S. Dept. of Labor (DOL) District Office in Cleveland.
- Must provide proof of diagnosis (medical records).
- Survivors must provide additional documentation, such as death certificate, proof of marriage, etc.,
- documenting relation to worker.
- Interview by claims administrator on job history, etc.

- DOL requests from BNL employment verification, radiation records, industrial hygiene records, training records, departmental records (job descriptions, etc.).

- DOL considers evidence and makes determination, process takes several months.

"Qualifying Cancers" Covered Under the Special Exposure Cohort

- Bone cancer (osteosarcoma)

- Renal (kidney) cancers

- Leukemia (other than chronic lymphocytic leukemia) provided the onset of the disease was at least two years after first exposure

- Lung cancer (other than in-situ lung cancer that is discovered during or after a post-mortem exam)

The following cancers are covered provided onset was at least five years after first exposure:

- Multiple myeloma
- Lymphomas (other than Hodgkin's disease)
- Primary cancer of the:

Bile ducts	
Brain	
Breast (female and male)	
Colon	
Esophagus	

Gall Bladder Liver Ovary Pancreas Pharynx (mouth/throat) Salivary gland Small intestine Stomach Thyroid Urinary Bladder

Note: Most common cancer types are covered by the SEC (exceptions: skin, cervix, prostate)

Free Medical Screening for Former BNL Workers

The Worker Health Protection Program (WHPP) of Queens College, City University of New York, offers nocost medical screening to former BNL workers who may be at an increased risk for illness due to working with or around radiation and toxic substances. The main goal of the screening is to detect illness at an early stage, when treatment is more likely to be effective. The program is voluntary, and all personal medical information is kept confidential. WHPP operates independently with funds from DOE.

The screening may identify a new health condition, confirm an existing one, or help relieve concerns about previous exposures. Participants receive examinations by an expert independent occupational medicine physician located in Suffolk County. Medical evaluations are based on potential work exposures to ionizing radiation, asbestos, lead, cadmium, silica, lasers, noise, beryllium and other hazards. Exposures such as these may lead to greater risk for developing certain conditions such as chronic lung disease, certain cancers, beryllium-related lung disease and hearing or vision loss.

After examination, participants receive a results letter with advice on any abnormalities and recommended follow-up care. If a potentially work-related illness is identified, the letter is often used to support claims under the Energy Employees Occupational Illness Compensation Program (see article above). Once you are enrolled in the program, you are eligible for a rescreening every three years. Rescreen examinations are recommended because many occupational illnesses can take many years after exposure stops before symptoms occur.

To date, over 350 exams have been performed for BNL former workers and over 30,000 workers have participated in the program at thirteen DOE sites nationwide.
