

More on Location Decisions

Ed. In the last issue we had to leave out some of Jim Hurst's article because of space limitations. Here is the part that was left out. In it he is explaining his motivation to leave LI. Please excuse the somewhat awkward format and remember it was extracted from the middle of the original.

Without knowing it at the time, I was developing some lessons learned based on my involvement in a civic (Brookhaven Village Association – 14 years on the Board), Town government (Brookhaven Town Solid Waste Advisory Committee – about 13 years), the LI Chapter of the American Society for Metals, now ASM Int'l. (most of my 37 years), several technical & curriculum related committees in the Pat-Med School District (~5 years), and at the Lab, Friends of Brookhaven. The last got me involved with the BNL Community Advisory Council. The period 1970s through the early 1990s saw many social & political changes; and, it was increasingly clear to me that the country was beginning to change in a way that would have long lasting effects. Technology was viewed as a bad thing. And, it was clear that more often than not - LI was on the cutting edge. Extremism, much of it on environmental issues, reared its ugly head. Proposed sensible precautions yielded to extreme and unjustified/unworkable solutions.

NIMBYism found an early home on the Island. The Hempstead Resource Recovery Plant was closed because of "dangerous levels" of dioxin emissions (read, it smelled sometimes). The Shoreham Nuclear Power Station was rebuilt three times at a final cost of \$6.4 billion. It was closed before it could be useful (read, no greenhouse gases) by the same politically powerful nuts that eventually closed the BMRR and the HFBR.

In the 1980s Grumman was having difficulty attracting professionals to Bethpage. BNL was seeing the same thing, and we didn't pay as well.

Brookhaven Town politicians agreed to host the ash from the new Hempstead Resource Recovery Plant and the Town became the garbage capital of LI. At BNL, the 1990s brought Adm. Watkins' Tiger Teams. They created quite a stir; but in the long run did little to improve things.

Local school costs were beginning to escalate, although the increases that you are seeing today, I never would have predicted.

My local favorite environmental problem came late in the timeline. That was the solution to the BNL spent fuel pool tritium leak where DOE, EPA, & some of our better connected citizens sent millions of gallons (costing millions of dollars) of LI ground water to Oak Ridge TN where it was injected into the local environment by using it to quench ash from a low level rad waste incinerator.

About 1985, we told our children that if they were going to college, we strongly recommended that they look out of state. And if they were planning to visit us in later life, they should not to look for us in NY. My wife & I had no idea where we were going – we just knew we were leaving. We were enjoying the Great South Bay and I certainly enjoyed BNL. Although I realized that I'd never get rich, I certainly wasn't ready to "get out of Dodge." My plan was to retire at about age 67. You all remember what happened next. AUI was replaced by BSA. Then came all those things like SBMS with its experimental reviews, endless meetings, and even monetary incentives. Business models were being applied to a most fundamentally chaotic human endeavor - basic research. Naturally, the lab "re-orged" more than a few times. Personally, I was happy to see that recently Solid State (Condensed Matter) Physics and Materials Science merged.

Are we sorry that we left? On the whole, the answer is no. We miss those who we left behind – some of our family and our friends, many from the Lab. Joan & I get back about once a year, and I usually get to BNL.

CAC Happenings

The CAC (Community Advisory Council) just celebrated its eighth anniversary and BREA has been there since the beginning (and before). We played a substantial role in its formation. It has become a very effective communication path, not only from the community to the Lab, but in the reverse directions also. It also has brought different segments of the community into touch with each other. BREA is represented by Graham Campbell with Arnold Peskin being

the Alternate Delegate. The major item currently being considered by the CAC is The Proposed Remedial Action Plan (PRAP) for the "g-2 Tritium Source Area and Groundwater Plume, Brookhaven Linac Isotope Producer Soils, and Former Underground Storage Tanks". This is part of a very formal process triggered by the inclusion of BNL on the so-called SuperFund List and CERCLA (which I won't attempt to expand). It will lead to a Record of Decision (ROD) that formally documents the actions to be taken to remediate the problem.
